

## “JINGLE BELL ROCK” OFFICIAL RULES

1. Winner must be 18 as of December 3, 2018.
2. Eligibility and Limitations. To be eligible, a contestant cannot have won a prize with a value of over \$500 from Manhattan Broadcasting (KMAN/KMKF/KXBZ/KACZ) in the past 6 months. Employees of Manhattan Broadcasting, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related. The person/person(s) who find and redeem the first Jingle Bell Rock will not be eligible to win the second prize package.
3. Contest begins Monday December 3, 2018 and continues until each “Jingle Bell Rock” is found and returned to Manhattan Broadcasting studios located @ 2414 Casement RD. Manhattan, KS 66502
  - a. Each weekday morning during the contest, the daily clue is read during the morning show on each respective station (KMAN/KMKF/KXBZ/KACZ). Time of daily reading will fall between the hours of 6am to 9am. The daily clue will be read once on air each day.
  - b. Daily clues will be available at sponsor locations after 10am.
  - c. Clues from each week will be posted online at 1015krock.com, newsradiokman.com, b1047.com and z963.com on Friday after 5pm.
  - d. Winner is the person who first finds and returns the “Jingle Bell Rock” to Manhattan Broadcasting, 2414 Casement Road Manhattan, KS 66502. The “Jingle Bell Rock” will be accepted and exchanged for prize package during regular business hours M-F 8:30-5:30.
  - e. The “Jingle Bell Rock” is considered not found and the contest still active until it is returned to and in possession of Manhattan Broadcasting.

- f. After the first “Jingle Bell Rock” is found and returned to the station, clues to find the second “Jingle Bell Rock” will begin on a date announced on-air on all four stations (KMAN/KMKF/KXBZ/KACZ).
4. The “Jingle Bell Rock” is hidden on public property. Any contestant who trespasses or damages any property public or private during the search for the “Jingle Bell Rock” will be automatically disqualified and all prizes forfeited and could be subject to arrest and/or damage complaints.
5. All persons searching for the “Jingle Bell Rock” will be considered contestants, and will hold Manhattan Broadcasting free from any liability of any damage to person or property arising from participation in “Jingle Bell Rock” promotional contest.
6. Value/Prize(s). The prize(s) that may be awarded to the eligible winner(s) are not transferable, redeemable for cash or exchangeable for any other prize. All prizes must be redeemed from the Radio Station within thirty (30) days of the contest end date, unless otherwise stated in the contest’s official rules. Certain prizes are date specific (i.e. concerts, trips) and the winner or winners must be available on the dates specified. Manhattan Broadcasting disclaims all liability for any delays, mis-delivered, loss, or failure in the delivery of any prize requested to be sent by mail. If a winner cannot be contacted or is disqualified for any reason, Manhattan Broadcasting reserves the right to determine an alternate winner or not to award that winner’s prize, in its sole discretion.
7. Publicity; Use of Personal Information. By participating, all participants and winner(s) grant Manhattan Broadcasting exclusive permission to use their names, characters, photographs, voices, videotape, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, participants agree that Manhattan Broadcasting may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.
